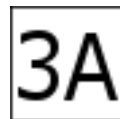

CONDITIONS FOR THE ASSEMBLY AND DISASSEMBLY OF STANDS

The Exhibitor and stand contractor acting on behalf of the Exhibitor are obliged to comply with the schedule of assembly works, terms and conditions of the PCI Days 2022 and the regulations of the EXPO XXI, in particular:

1. The contractor is obliged to perform all assembly and disassembly works in accordance with the previously approved architectural plan of the building and in compliance with the applicable safety rules, in particular in the scope of occupational health and safety regulations, in accordance with the principles of art and respect for the facility.
2. The Exhibitor bears full responsibility for the safety and health of all people working at the assembly and disassembly of the stand and during the fair and is responsible for all accidents resulting from the lack of supervision or neglect of work safety requirements. All persons and entities executing stand construction on behalf of the Exhibitor must have valid certificates of the OSH training.
3. The Exhibitor is obliged to have full insurance of all the effects of assembly, equipping and disassembly of the stand, as well as its exhibits, other equipment for which it is responsible and personal items.
4. The Exhibitor is obliged to notify the Organizer immediately about any identified hazards, accidents or damages.
5. The Exhibitor is obliged to follow the protection instructions issued by the owner of the facility and its representatives. All complaints regarding damages incurred by the Exhibitor shall be reported to the Organizer in writing and during the fair and assembly and disassembly of stands. The Exhibitor covers the costs of damages caused to the property of the owner of the facility or caused to other entities and third parties by the Exhibitor, his representatives, companies and persons working for the Exhibitor and third parties who by the will of the Exhibitor stay at EXPO XXI during the fair and the assembly and disassembly of stands..
6. The stand contractor has the right to perform only the necessary assembly works and final retouching during the assembly and disassembly executed within his stand. It is not allowed to perform any basic works (carpentry, painting, etc.) related with the preparation of the stand and exhibits. In particular, welding, sanding wood and plaster as well as other dusting works are forbidden.
7. The stand and its equipment should be assembled in such a way that they do not pose a threat to public safety and order, and in particular to the life and health of persons staying at the fairgrounds.
8. During assembly and disassembly, the contractor cannot itself connect or disconnect electrical switchboards in media channels and walls.
9. No elements of the building can be located beyond the allocated exhibition space, block passages and passageways as well as the approved construction height in any way.
10. **The Exhibitor may start to remove their exhibits and other items which belong to them from the stand no earlier than June 23rd, 2022 at 3:30 PM.**

The contractor is obliged to systematically remove all packaging and assembly waste during the assembly and disassembly of the stand. All elements of the disassembled stand with exhibits must be removed from the site by the contractor in accordance with the schedule. It is forbidden to throw away the elements of the disassembled stand into the garbage containers on the premises. The contractor will pay special attention to the removal of the floor covering and assembly elements (strip remains) and leave the hall floor free of glue and dirt. If the above-mentioned cleaning works are not carried out within the deadline, the Organizer will commission them at the expense and risk of the Exhibitor.
